And whereas the said land claim has been referred to the Land Claims Court ("the Court");

And whereas the Court has begun hearing the trial of the land claim;

Now, therefore, please take notice that -

1. the trial has been adjourned to 30 October 2017 for resumption of hearing at 10 am in the Land Claims Court to be held at Port Alfred Magistrate's Court;
2. if you wish to participate in the trial, you must within two weeks of your receipt hereof give notice of your intention to do so by handing, faxing, emailing or sending it by registered mail to the Registrar of the Land Claims Court at:

3. your notice must contain an address for delivery to you of further documents in the case, which address must be the address of your attorney or a physical address within 8 kilometres of the Land Claims Court, Randburg, set out above or the magistrate's court for the district of Nqgushwa/Port Alfred Magistrate's Court.
4. If your notice does not reach the Registrar and the other parties involved in this case in time -
 - 4.1 you will not receive further documents in this case and you may not participate in the case; and

- 4.2 the Land claims Court may give a judgment which affects you without giving you any further notice.
5. If your notice is received in time you must file a plea within three weeks of receipt of the transcript of proceedings to date or notification of the availability of such transcript.
6. Annexed to this notice is a copy of the court's order regulating the further conduct of this matter and a flash disk containing an electronic copy of the documents filed in this case to date.
